An Act to amend the Indian Extradition Act, 1903.

WHEREAS it is expedient to amend the Indian Extradition Act, 1903; It is hereby enacted as follows:—

- 1. This Act may be called the Indian Extradi-Short title. tion (Amendment) Act, 1913.
- 2. (1) In sub-section (1) of section 7 of the Amendment of Indian Extradition Act, 1903, after the words "such xv, 1903, person is believed to be," the words "or if such person is believed to be in any Presidency-town to the Chief Presidency Magistrate of such town" shall be inserted.
- (2) In sub-section (2) of the same section after the words "accused person when arrested shall" the words "be produced before the District Magistrate or Chief Presidency Magistrate, as the case may be, who shall record any statement made by him; such accused person shall then" shall be inserted.
- (3) In sub-section (3) of the same section after the words "District Magistrate," the words "or Chief Presidency Magistrate" shall be inserted.
- 3. After section 8 of the said Act the following Addition of section shall be inserted, namely:—

- "8A. Notwithstanding anything contained in section 7, sub-section (2) or in section 8, when an acport case for cused person arrested in accordance with the provisions Government. of section 7 is produced before the District Magistrate or Chief Presidency Magistrate, as the case may be, and the statement (if any) of such accused person has been recorded, such Magistrate may, if he thinks fit, before

before proceeding further report the case to the Local Government and, pending the receipt of orders on such report, may detain such accused person in custody or release him on his executing a bond with sufficient sureties for his attendance when required."
