[Passed by the Indian Legislature.]

(Received the assent of the Governor General on the 22nd February, 1922.)

An Act to repeal certain special enactments supplementing the ordinary criminal law.

WHEREAS it is expedient that certain special enactments supplementing the ordinary criminal law should be repealed; It is hereby enacted as follows:—

- 1. This Act may be called the Special Laws shortentle. Repeal Act, 1922.
- 2. The repeal of any enactment by this Act shall Extent, have effect in every 1 art of British India, including British Baluchistan, the Sonthal Parganas, the Shan States and the Hill District of Arakan, in which the enactment was in force at the date of the commencement of this Act, and any notification, made under any law for the time being in force, whereby any such enactment has been declared to be in force in, or applicable to, or has been extended to, any such part, shall on and from that date be deemed to have been cancelled in so far as it relates to that enactment.
- 3. The enactments mentioned in the Schedule are Repeals, hereby repealed to the extent specified in the fourth column thereof.
