## An Act further to amend the Indian Tariff Act, 1934.

XXXII of 1934 **W**HEREAS it is expedient further to amend the  
 Indian Tariff Act, 1934, for the purpose of assist-  
 ing the sale in India of wheat produced therein by  
 imposing a temporary duty of customs on the impor-  
 tation of wheat; It is hereby enacted as follows :—

1. This Act may be called the Indian Tariff (Amend- Short title.  
 ment) Act, 1939.
